#### 4.1. Description of first aid measures

##### General information

#### 4.2. Most important symptoms and effects, both acute and delayed

Intolerance to alcohol can occur up to 4 days after exposure to dimethylformamide. Dimethylformamide is considered to be a potent liver toxin. Vomiting, Diarrhoea, Abdominal pain.  
Irritation effects: This product contains substances, which may cause irritation upon exposure to skin, eyes or lungs. Exposure may result in an increased absorption potential of other hazardous substances at the area of exposure.  
Neurotoxic effects: This product contains organic solvents, which may cause adverse effects to the nervous system.
